Shortlisting of candidates for Additional Document verification for CEN. 03/2019
Ministerial & Isolated category Posts

1. Based on the performance in the CBT conducted from 15.12.2020 to 18.12.2020 & on 07.01.2021 and stenography skill test from 27.10.2021 to 02.01.2022 by the RRB – Ahmedabad for various posts of ministerial & isolated categories under CEN 03/2019 and option furnished in their online applications, candidates bearing the following roll numbers arrange in ascending order (not in order of merit) horizontally have been provisionally shortlisted for Document Verification and Medical Examination held on **16.01.2023**
2. The result for various notified categories has been prepared based on the principals/process laid down in para 13.0 of detailed CEN.
3. Normalization of raw marks has not been done since CBT exam for concerned category was conducted in single shift only. No normalization is application for stenography skill test.
4. The candidates equal to number of notified vacancies, subject to availability of eligible candidates, have been shortlisted for document verification and medical examination.
5. In case of two or more candidates securing same marks, their merit position has been determined by age criteria older person has been placed at higher merit and in case age being same than alphabetical order (A to Z) of the same has been taken into account to break the tie.
6. If a candidate has applied and appear in more than one category consenting of distinct question paper based on his / her eligibility and post preference, he / she, if shortlisted based on merit, has been shortlisted accordingly in multiple category as per his/her merit.
7. The shortlisted candidates will be informed through official websites/Email (provided in their application) about the actual date and place of Document Verification.
8. The candidates called for DV should produced all the original documents along with two sets of zerox copies in A4 size as detailed in the CEN and E-call letter issued for DV.
9. Those candidates who will be called for documents verification may not that after completion of DV they will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of concerned RRB on the next day of DV. The candidates are required to come prepared to stay for 3 to 4 days accordingly. Candidates have to pay the prescribed medical fee of Rs.24/- only. There are no other charges to be paid to the hospital / health unit for the medical examination, in rare cases, where the investigation likes CT Scan, Ultrasound, Test to ruled out refractive eye surgery etc, have to be paid out which necessary facilities is not available in the Rly Hospital / Health unit then for such investigation, candidates may have to make the requisite payment to the concern laboratory / hospital.
10. The candidature of all the shortlisted candidates is purely provisional and liable to be cancelled at any stage of recruitment or their after, in case of any inconsistency / deficiency / discrepancy detected in the information furnished by them in the online application or any malpractice on their part coming to the noticed at any stage of the recruitment process or their after.
11. It is to be noted that merely shortlisting or call a candidate for DV / Medical Examination dose not entitled him / her in any way to an appointment in the railway.

12. While every care has been taken in preparing the result, RRB reserved the right to rectify any inadvertent error or typographical / printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.
